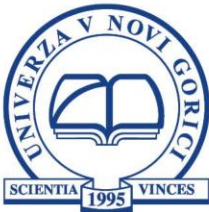

Step 1

- Attach all supplemental documents you already have to the application. Certificates that were not issued to you at the time of application can be attached to the application later.
- **Special note: candidates will need to enter the eVs web portal during application period, therefore it is necessary to retain the username and password for eVs web portal!**
- Click a large submit button. You will be notified of the submitted application to the e-mail address you provided in the application.
- The application for enrollment and the related procedures will be made electronically via the eVŠ portal, including all the required supplemental documents and the notification of selection.
- Higher education institutions must conduct a direct interview with any foreign citizen coming from a country with higher migration risk and whose citizens must have visas when crossing the external borders of the European Union. The interview assesses the candidate's suitability in relation to the admission requirements of the study programme. Candidates will receive instructions at the contact email address they provided in their application for enrolment.

- Candidates who have already completed secondary education at the time of application and have proof of eligibility (final exam, secondary school completed abroad ...) and which cannot be obtained from public records, submit them electronically via the eVŠ portal **together with the application**, or at the latest by the end of the application period in which they submit the application.
- Candidates who complete secondary school in the current school year must submit evidence to the eVŠ portal **by the above-mentioned date**.

# From application to study

1. Apply for study via evs web portal
2. Add necessary documents by the deadline
3. Pass interview (foreign citizen coming from a country with higher migration risk and whose citizens must have visas when crossing the external borders of the EU)
4. Wait for an acceptance note (after closure of the application)
5. Wait for invitation for enrolment (check also spam folder)
6. Enroll by the deadline (send application form and cover tuition fee if necessary)
7. Apply for Temporary residence permit (at local administrative unit in Slovenia if you can enter without visa OR at the Embassy of Republic of Slovenia if you can not enter without visa)
8. Search for accommodation
9. Start your studies!
